U.S. Physical Therapy Makes 14 Clinic Acquisition in Southeast

Houston, TX, January 3, 2011 – U.S. Physical Therapy, Inc. (NASDAQ: USPH), a leading national operator of outpatient physical therapy clinics, has acquired a majority interest in a 14 clinic physical therapy group located in the Southeast. The practice presently sees approximately 100,000 patient visits per year and produces approximately \$9.0 million in annual revenue. The purchase price for U.S. Physical Therapy’s 65% acquired interest was \$4,770,000 which was financed with available cash, borrowings under the Company’s credit line and a seller note.

Founded in 1990, U.S. Physical Therapy, Inc. operates 393 clinics in 42 states. The Company's clinics provide preventative and post-operative care for a variety of orthopedic-related disorders and sports-related injuries, non-surgical treatment of osteoarthritis, treatment for neurologically-related injuries and rehabilitation of injured workers. In addition to owning and operating clinics, the Company manages physical therapy facilities for third parties, including hospitals and physician groups.
